## **EFFECTIVE DATE**

## **PURPOSE**

The purpose of this bulletin is to notify City of Los Angeles (City) Workforce Development System (WDS) contractors and partners that the Economic and Workforce Development Department (EWDD) is hosting a virtual community forum to solicit public input for the draft Program Year (PY) 2026-27 Annual Plan (Annual Plan).

## **BACKGROUND**

The Annual Plan covers the service strategies, activities, and budget for the City's WDS. It outlines how the City will deliver services and meet the objectives of promoting a trained workforce with access to good jobs and a strong business/employer regional economy. A draft of the Annual Plan was posted on Thursday, April 2, 2026 and will be available for a 30-day public comment period through Saturday, May 2, 2026.
